Thank you for registering to use the Robert E. Post Park. The park is located off of Ulster Landing Road, at the end of Park Road, on the Hudson River.

It is opened for functions from May 1st to Oct. 31st. Presently, there are two pavilions available on a first come first served basis, starting from January 1st of each year.

The large pavilion, centrally located on the park grounds, accommodates up to 250 people. It is equipped with electricity, a kitchen & a barbecue pit.

The small pavilion, located on the northern side of the park, accommodates up to 50 people. It is equipped with electricity and barbecue facilities. The restrooms are available to all at the large pavilion.

The park has a playground and a large playing field, as well as smaller fields for softball, volleyball and bocce ball. These amenities are available to all and we ask for your cooperation in sharing them.

There is a park attendant on duty that will supervise use of the facility and maintain the rules. Cooperation with his requests is appreciated.

- 2) NO SWIMMING ALLOWED.
- 3) NO ANIMALS ALLOWED.
- 4) NO COOKING OR FIRES ALLOWED UNDER THE PAVILIONS.
- 5) REFUSE MUST BE PUT INTO PROPER CONTAINERS AND THE AREAS MUST BE CLEANED BEFORE LEAVING. TABLES MUST BE RETURNED TO THEIR ORIGINAL POSITION.
- 6) USE OF THE ATHLETIC FIELDS ARE LIMITED TO TWO HOURS.
- 7) RIDING OF MOTORCYCLES OR MOTORIZED BIKES AROUND THE PARK GROUNDS, OTHER THAN ON ROADWAYS, IS STRICTLY PROHIBITED.

*** ALCOHOLIC BEVERAGES ARE ALLOWED PROVIDED THAT SUCH A GROUP HAS PROCURED INSURANCE COVERAGE LISTING THE TOWN OF ULSTER AS AN ADDITIONAL INSURED IN AN AMOUNT OF NOT LESS THAN ONE MILLION (\$1,000,000.00) AND FILED WITH THE TOWN CLERK NO LATER THAN 10 DAYS PRECEDING, SUCH EVENT.
